# 4. Data Protection and Privacy

- All Images will be stored by the Club and its representatives
- Images will not be sold or licensed for unrelated commercial purposes
- Requests to restrict use of specific Images may be submitted in writing and will be reasonably considered

### 5. Duration of Consent

This consent remains valid indefinitely unless formally revoked in writing. Images used prior to a revocation may remain in already-published materials.

# 6. Release of Liability

 You release Windsor Polo Club and its representatives from any claims, demands, or liabilities in connection with the described Image use

- Participation in Club events is not contingent on consenting to photography; if you wish to opt out, notify the Club before or during your participation
- The Club does not guarantee your Images will be used

### 7. Opt-Out Procedures

- If you do not wish to have your photograph or image used, please inform a Club representative and submit a written request to Club administration before the event or booking
- The Club will make reasonable efforts to honour opt-out requests, though cannot guarantee exclusion from all group or crowd photography

### 8. Consent for Minors

If the Participant is under 18 years of age, consent is deemed granted by the parent or guardian completing payment and booking on behalf of the minor.
